PACANZ Annual General Meeting 2013 - Report

The 2013 AGM was held on April 13th in Palmerston North. The meeting was attended by 44 delegates and Life members which was one of the largest AGM's in recent times.

The following items were voted on:

- **Subs** for 2014 remain at \$120
- Entry Fees and Apra Levies were discussed and the new calculation and costs are presented later in this news-
- Auditor for 2013/2014 is Mead Stark
- Patron remains as Sir William Southgate
- Deanna Watson was re-elected as President of PACANZ
- Tracey Andrews was re-elected as the Central North Island delegate
- Sonia van den Yssel was re-elected as the Southern South Island delegate
- Bronwyn Jensen was re-elected as Northern North Island delegate & as Vice President
- 2 new Life Members were presented to the Membership: Fay Hay and Deanna Watson have both been on the Board for more than 10 years and

their Life Membership status was presented in recognition of this generous contribution of both their time and knowledge

- The <u>Venue</u> for the <u>2014 Annual</u> General Meeting is to be confirmed. The Board will look at possible venues at their Board meeting following the AGM. Queenstown is a possibility for the South Island.

The 2013 Conference was held in the afternoon and consisted of 2 presentations. Michael Smit from Cotton Kelly Audit presented on a Financial Warrant of Fitness for Not for Profit organisations and Mark von Dadelszen, honorary solicitor for the NZ Singing School Trust, spoke on NZ Copyright law and the ramifications for performing arts. Both speakers were well received and proceeded to immerse the attendees with their knowledge on their respective areas of expertise. A thoroughly enjoyable, educational and thought provoking afternoon.



2014 Entry Fees and Apra Levies

The set format, for a Society to support PACANZ via the payment of a small part of their competition entry fees, has been working well. Slight increases over the years have managed to maintain minimum impact on the Societies and their competitors, while still assisting financially in the day to day running of PACANZ and the National Young Performer Awards.

The Apra levy that PACANZ collected from Societies on behalf of APRA, was as a result of PACANZ negotiating a 'special rate" for it's member societies. This "special rate" also allowed societies to waive the usual compliance required, in terms of the volumes of APRA paperwork regarding recorded and live music for performance. The calculation used was a percentage of door takings, which for 2013 was 1.15%. Over the past 12 months, more and more Societies have been waiving their door fee i.e. no longer have a volunteer on the door and either do not charge a door fee at all, or include it in their other fees for competitors. This has resulted in not all societies paying the 1.15% negotiated with APRA and therefore not being covered by the PACANZ collective agreement.

The Entry fee portion paid to PACANZ was also due for an increase and when this issue was discussed at the 2013 AGM, the following was decided on by the meeting, as the most practical way to collect the Apra Levies, which ensures that all member societies are covered for use of music.

In 2014 the Entry fee paid to PACANZ will include a portion to be paid to APRA and will be:

Modern Jazz, Ballet, Tap, Instrumental and Piano - 65c for every item entered in any of the Competitions for these art forms, held by the Society during the year

Highland and Speech & Drama- 60c for every item entered in any of the Competitions for these art forms, held by the Society during the year.

Societies were reminded that this fee is applicable to ALL entries in ALL competitions held and that they should send in a copy of their programme with their payment as part of the audit trail. New forms will be sent out in the new year for 2014 Competitions.

I would like to wish societies, teachers, parents, competitors all the best for their competition year. A big thanks for all the support and the hard work going on behind the scenes.
